IP Address Request and Justification Form

Note: completion of this form is mandatory when requesting IP addresses greater than the default provisioned amount for the datacenter you have chosen.

GlowHost.com, LLC abides to the policies of the American Registry for Internet Numbers (ARIN) regarding IP address allocation. As part of standard service provided, GlowHost.com will assign the amount of IP addresses that customers can justify for use on their hosting server(s). Written justification for any additional IP address(es) requested is required so that we can demonstrate to ARIN that IP addresses allocated to GlowHost.com are being used efficiently.

IPs may only be allocated to servers or cases where name-based hosting is not possible due to technological limitations such as SSL, nameservers, private networks and similar. IPs may not be allocated whereby not all are used for valid ARIN-mandated purpose.

SEO is not a valid justification for IP assignments.

Here is why: Google and every other major search engine is smarter than that. Different IPs on different subnets does nothing for your Google page ranking. While some schools tell you that all of your domains should be on different subnets or different IPs, this is false. Google knows that Ipv4 space is limited and they also know the situation where a single IP may share millions of domains. They have no reason to penalize for name based hosting since that is how most of the internet is hosted. Don't believe us? Google it!

These are not GlowHost's rules, these are ARIN rules. Every responsible IP service provider and host is expected to follow these rules. Those who do not are in violation of ARIN rules and you might find yourself with no IPs by using a service like this. Because of this, if you are shopping for a host for this specific reason, use caution.

If you understand this, and you can justify the usage of your prospective IP addresses, we will provide them to you with your completed justification form.

We require an explanation of why you need each IP, the domain it's for, and why you can't use named-based hosting.

Please keep in mind, we examine each and every IP address request to see if the domain name you need it for is currently using services that require an IP. Services such as SSL, name servers, VPN, etc.
